This matter was before the Court on October 31, 2024, at 2:00 p.m. upon the Defendant's Motion for Reconsideration of Sentence. This motion was made by and through, J. Falkner Wilkes, Esq., by Motion timely filed with the Court. At the hearing held in this matter, the State was represented by William G. Rhoden, Esq., of the Seventh Circuit Solicitor's Office. The Defendant was also present. The hearing was conducted in person.


It appears that the Defendant was charged with the crimes Shoplifting Enhanced and Assault. She pled guilty to the offense of Shoplifting, with a value of \$1,000 or less, a misdemeanor, with a potential penalty of 0-30 days and/or a fine of \$0-\$1,000. The Defendant received a sentence of time served giving her credit for 7 days that she spent in pre-trial detention. She was also required to pay restitution to Dollar General in the amount of \$7.50, and was to have no future contact with the Dollar General/s in Chesnee, SC.
