PLEASE CONSIDER THE FOLLOWING FACTS TO MY CASE. CHRISTOPHER MURPHY WAS RETAINED AS MY COUNSEL DURING 2017 AFTER MY ARREST. HE WAS GIVEN \$7,500 UP FRONT AND \$1,000 EACH MONTH AFTER. I WAS TRANSPORTED FROM COLLETON COUNTY JAIL TO THE MAGISTRATE OFFICE FOR MY PRELIMINARY HEARING AND MR. MURPHY NEVER SHOWED UP. I TOLD THE JUDGE I WANTED TO WAIT UNTIL MY COUNSEL WAS PRESENT AND HE RESCHEDULED MY PRE-LIM. I WAS TAKEN BACK TO PRE-LIM A FEW WEEKS LATER AND AGAIN AND AGAIN MR. MURPHY DID NOT SHOW UP, SO THE SOLICITOR SETH UTSEY SAID THAT THEY WERE DIRECTLY INCITING ME. MR. MURPHY STATED AT MY PCR HEARING THAT I WAIVED MY RIGHTS TO A PRELIM, BUT THAT IS NOT SO. MR. MURPHY COULD NOT PRODUCE ANY PAPERWORK AT MY PCR HEARING SHOWING THAT I SIGNED MY RIGHTS TO A PRE-LIM. I HAVE WRITTEN TO MR. MURPHY'S OFFICE ASKING FOR HIM TO SEND ME COPIES OF WHERE I SIGNED MY RIGHT TO A PRE-LIM AWAY, AND FOR PRINT OUTS OF THE CONVERSATIONS

BETWEEN HIM AND THE SOLICITOR, I SENT THE LETTER CERTIFIED AND HIS OFFICE RECEIVED IT ON OCT, 12 2024, BUT HAVE STILL NOT SENT ME ANYTHING, AND THATS BECAUSE THERE IS NOTHING THAT HE CAN SHOW WHERE I SIGNED MY RIGHT TO A PRE-LIM AWAY, BECAUSE I NEVER DID. I BELIEVE THAT HIM NOT SHOWING UP PROVES INEFFECTIVE ASSISTANCE OF COUNSEL UNDER (CHERRY V STATE). MR. MURPHY ALSO ALLOWED ME TO PLEA TO SAFE CRACKING, AND ACCESSORY AFTER THE FACT TO SAFE CRACKING FOR THE SAME SAFE WHICH IS ME BEING DOUBLE CHARGED FOR THE SAME CRIME. I BELIEVE THAT HAD MR. MURPHY HAD SHOWN UP TO MY PRE-LIM THAT THIS ERROR COULD HAVE BEEN CORRECTED AND WOULD HAVE RESULTED IN ME BEING ABLE TO RECEIVE A BETTER PLEA OFFER. I BELIEVE THAT THIS SHOWS PREJUDICE TO MY CASE AND A JURISTISWAL ERROR AND PROVES MY SECOND PRONG UNDER (CHERRY U. STATE). MR. MURPHY TOLD ME I WOULD BE GETTING

BETWEEN 12-15 YEARS AND I RECEIVED
22 YEARS. IF GIVEN TO OPPORTUNITY I WILL
GO TO TRIAL. MR. MURPHY WAS RUNNING
FOR A SEAT IN LEGISLATION AT THE
TIME OF MY COURT HEARINGS AND I
FEEL HE PUT THAT OVER MY CASE. TWO
WEEKS AFTER HE RECEIVED MY FINAL
PAYMENT TO HIM HE TOLD ME TO PLEA
TO A OPEN PLEA.
