
MOTION FOR EXTENSION OF TIME TO FILE APPELLANT'S SUPPLEMENTAL RECORD ON APPEAL



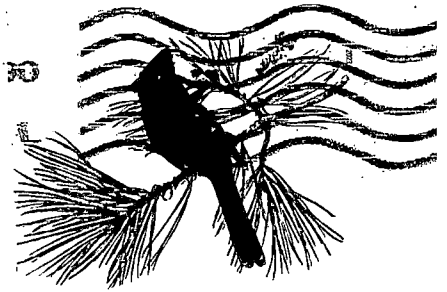
