Dear Clerk of the Court,

I am writing to clarify inaccuracies in Ms. Donna Moore's recent statement regarding her receipt of court filings and to request that she provide an updated address on the record.

To begin, Ms. Moore has not filed an official appearance in the Court of Appeals, nor did she register her appearance or participate in the appeal process in the circuit court. As such, she has not formally engaged in the appeal process and has not followed the requirements for receiving notices on appeal matters.

Although Ms. Moore waived her right to official service, I have been sending her copies of filings by mail as a courtesy. Additionally, she has been receiving all court-related filings via email, which she designated as her primary communication method in this case.

The amended notice of appeal was filed on the evening of Friday, November 1, 2024, and an email copy was promptly served upon Ms. Moore. A physical copy was also mailed, which she should receive within a few days.

Furthermore, Ms. Moore has not submitted any documentation to update her address on the record, nor has she responded to any filings despite having knowledge of them. Having an updated address on file will support efficient and verifiable delivery of all mailed documents.
