**MOTION REQUESTING PERMISSION
TO ORDER AND FILE FINAL HEARING TRANSCRIPT**

Appellant Racquel Bolden-Lott, pro se, pursuant to Rule 207, South Carolina Appellate Court Rules, hereby moves this Court of Appeals for permission to order and file the final hearing transcript of the proceedings below resulting in the *Judgment and Final Order* filed on September 13, 2024, in the Courts of Common Pleas, Civil Action No. 2022-CP-07-01741, and states:

1. On September 28, 2024, I telephoned Court Reporter Theresa D. Saxon who recorded the Final Hearing of September 9, 2024, before the before the Honorable Curtis L. Coltrane, Special Referee. I advised her that I intended to appeal the *Judgment and Final Order* of September 13, 2024, and that I asked her to provide me with the cost so that I could order the final hearing transcript. I also provided Ms. Saxon with my email address – rockyblott50@gmail.com – so that she could forward the invoice.

2. On October 11, 2024, I filed the *Notice of Appeal* and on October 24, 2024, I filed the *Amended Notice of Appeal*.

3. On November 12, 2024, the Chief Deputy Clerk Catherine Harrison wrote a letter advising me that the time to order and file the final hearing transcript had expired.

4. On November 18, 2024, I telephoned Court Reporter Theresa D. Saxon who advised me that she sent her email and cost information to order the hearing transcript to a wrong email address: rockylott@gmail.com. She immediately forwarded her email of October 3, 2024, confirming that “earlier [that] week” on Monday, September 28, 2024, I called her asking that she provide me with the cost to order the final hearing transcript. (Copy attached as Exhibit “A”)

5. On November 21, 2021, Court Reporter Theresa D. Saxon emailed me providing me with an invoice and she stated that due to recent surgeries for left carpal tunnel syndrome, an osteotomy of the foot and surgery for right carpal tunnel syndrome scheduled next week, she can provide the final hearing transcript at the end of December 2024 or early January 2025. 6. WHEREFORE, Appellant Racquel Bolden-Lott, pro se, respectfully

request the South Carolina Court of Appeal grant permission to order and file the final hearing transcript outside of the filing deadlines set by Rule 207, South Carolina Appellate Court Rules.
