Although information was given to Ms Erica Williams at the ODC regarding the change & new phone numbers, there were 2-3 wills, one which was unsigned, where they left me out completely and had my oldest sister, my dad's stepdaughter as the Executor of his estate something my father would have never done. The will was prepared & notarized at a hardware store versus a reputable attorney. Girlfriends were in the will yet I was not. If they had their way I would have gotten nothing. I was retaliated against in so many ways to prevent me from fighting for my father's estate, and because of my complaints. I was wrongfully hospitalized & drugged against my will on 2 separate occasions - 2 involuntary commitments 1 in the VA Hospital another in Prisma Health. Each time I was caused physical harm. Once by my uncle & then at 230 Deerbound Trail. - In an attempt to defame my character, question my mental stability and try to have me sign over power of Atty to my sister Renee Palmer. It was caused undue harm, rendering me dysfunctional.

Page 3 of 3 Dec 2, 24

I've been forced to move from place to place due to civil & human rights violations. I was stripped of my right to drive making my life so much harder to live - only allowed to survive.

A girlfriend should not be allowed to receive any portion of my Dad's estate, nor should my Aunt or Uncle, and especially not more than his Daughter.

A step daughter who doesn't even bear his name, or a niece of a deceased sister should not get his money either.

There are only 2 legitimate heirs.

Myself, Janet Palmer-Carri, and Renee Palmer. My life has been turned upside down & I'm still trying to recover from the damage. The police involved have not been held accountable, yet. No one has been held accountable, not even the VA.

I ask you is this justice, or injustice?

Also I believe this was done in an effort to possibly give my portion to a Janice Palmer vs me. Janet Palmer-Carri.

I pray that you'll find in my favor and grant the reinstatement & reconsideration.
