MOTION TO REINSTATE APPEAL


The undersigned counsel moves the Court to reinstate the direct appeal of Telvin Quintavis Jackson. In support of this motion, counsel would respectfully show the Court that:

1. Trial counsel served and filed the notice of intent to appeal on July 22, 2024.
2. The Office of Appellate Defense timely ordered the transcript from the court reporter on September 20, 2024. The transcript request and cover letter to the Court Reporter are attached to this motion as Exhibit A. This Court was copied on this transcript request, as were opposing counsel, the Attorney General's Office, and Court Administration. 
