AFFIDAVIT OF INDIGENT APPELLANT/DEFENDANT IN SUPPORT OF MOTION  
FOR APPOINTMENT OF COUNSEL

Appellant, hereby state and affirm as follows:

1. I am the Appellant in the above referenced case.
2. The allege Grand Jury of Richland County on filed indictments against me for (3) counts of carjacking (2007-GS-40-2000; 2001; 2002) two (2) counts of Kidnapping (2007-GS-40-2003; 1938) One (1) First Degree Burglary (2007-GS-40-2048); Assault with intent to kill (2007-GS-40-1939); and Assault and Battery of a High and Aggravated Nature (2007-GS-40-1940.
3. I was arraigned in the County of Richland on March 30, 2009 through April 3, 2009, and pleaded not guilty to alleged indictments.
4. I am presently incarcerated at Allendale Correctional Institution County of Fairfax, as a result of my indictments and accordingly, I am unemployed and unable to obtain employment here in the South Carolina Department of Corrections.

5. I am absolutely destitute and own no property of any kind whatsoever, nor are there any money or property due and owing to me from any person.

6. I am unable to retain and pay counsel to defend me or pay any incidental expenses which may be incurred in the conduct of my defense.

7. substantial issues as to whether Appellant's Constitutional and due process rights were violated, issues raised in litigation of violations are so complex that Appellant is not capable of handling them effectively, due to medical problems (glaucoma both eyes) and more over he is not trained in law, very limited law library hours, and justice would best be served in this case if an attorney is appointed.

WHEREFORE, Appellant pray that request be granted.

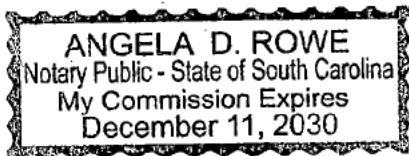

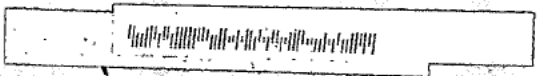
