This appeal was dismissed by order dated September 16, 2024. Consistent with your letter of November 8, 2024, the remittitur should have been sent on November 25, 2024.

Since November 8, I have not been served with a motion to reinstate. Instead, I received the attached two pages in an envelope post-marked November 26 (Attachment 1). The first page is titled "Proof of Service of Motion to Reinstate;" however, the second page is not a motion to reinstate. Instead, Ms. Morrell states:

I'm am requesting relief from Court proceedings before Judge Erin Vaux, Magistrate Court Case No. 2024CV0710300224 on April 11, 2024. Court proceedings before Judge S/R Lawton McIntosh, Circuit Court Judge, Case No. 2024-CP-07-00775. In references to Court proceedings Appellate Case No. 2024-001091. I am requesting relief regarding Clerical errors of court and also on grounds asserted in evidence of Rental History Ledger from Beaufort Housing Authority showing credit on my account, before the proceeding on April 11, 2024, therefore I could not owe any rent, because I have paid rent in advance and I currently have a credit money balance dating from last year April 2023-until present.

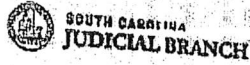

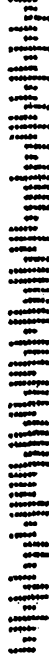
