

On November 21, 2024 the Appellant was found Guilty by Jury Trial on Grand Larceny, value \$10,000 or more (NMT 10 years or discretionary fine) (Indictment No. 2024-GS-46-00544), Airport / Unlawful entry of aircraft, damaging, or removing equipment (Indictment No. 2024-GS-46-00545), Contributing to the Delinquency of a Minor (NMT 3 YEARS &/OR \$3,000) (Indictment No. 2024-GS-46-00546), Airport / Unlawful entry of aircraft, damaging, or removing equipment (Indictment No. 2024-GS-46-00547), Burglary, Second Degree (Violation) (NMT 15 years) (Indictment No. 2024-GS-46-00553), Grand Larceny value more than \$2,000 but less than \$10,000 (NMT 5 years or discretionary fine) (Indictment No. 2024-GS-46-00554), Airport / Unlawful entry of aircraft, damaging, or removing equipment (Indictment No. 2024-GS-46-00555), Burglary, Second Degree (Violation) (NMT 15 years) (Indictment No. 2024-GS-46-00556), Grand Larceny value more than \$2,000 but less than \$10,000 (NMT 5 years or discretionary fine) (Indictment No. 2024-GS-46-00557), Airport / Unlawful entry of aircraft, damaging, or removing equipment (Indictment No. 2024-GS-46-00558), and Contributing to the Delinquency of a Minor (NMT 3 YEARS &/OR \$3,000) (Indictment No. 2024-GS-46-00552).

The Appellant received a ten (10) year sentence on Indictment No. 2024-GS-46-00544, a ten (10) year sentence on Indictment Nos. 2024-GS-46-00553 and 2024-GS-46-00556, a five (5) year sentence on Indictment Nos. 2024-GS-46-00554 and 2024-GS-46-00557, a five (5) year sentence on Indictment Nos. 2024-GS-46-00545, Nos. 2024-GS-46-00547, Nos. 2024-GS-46-00555 and Nos. 2024-GS-46-00558, and a three (3) year sentence on Indictment No. 2024-GS-46-00546. The above sentences are to run concurrent and with three hundred and seventeen (317) days credit for time served.

The Appellant received a three (3) year sentence on Indictment No. 2024-GS-46-00552. This sentence shall run consecutive to sentence on Indictment No. 2024-GS-46-00553 and with three hundred and seventeen (317) days credit for time served. The Appellant received a Time Served sentence on Indictment No. 2024-GS-46-06068.


