
Affidavit of

PERSONALLY Appeared Before me, the undersigned for Administering Oath, Appellant Stating: That my name is Herbert Alonzo Robinson, Appellant above named.

1. I am currently confined at the South Carolina Dept. of Corrections (SCDC), serving a conviction for Burglary Second Degree with an Early Release date of 2014.
2. I am unable as an Indigent to comply with the Courts order of August 9, 2013, giving me 15 days to pay filing fee, when my prison account balance is \$0.00 (Zero Dollars). I ask for the Appellate Court to issue an order that prison officials debit my account to pay Installments on the filing fees as funds in my account becomes available. (I received courts order 8/12/13 via Mailroom.)
3. I would further ask this Honorable Court to Consider this Appeal under Special Circumstances, since it involves violation of Appellants' Right to Access to the Courts, wherein

Respondent, Cannon employee Intentionally
seized/confiscated over 1800 pages of Legal
Materials while Appellant was a Pre-Trial
Detainee and Destroyed it in Retaliation for
Grievance and Lawsuit filed surrounding the
Incident. The Legal materials were part of Appellants
Criminal and Civil Defense and Appellant could
Not proceed to Trial (without it) and was herein
Convicted.
