Thank you so much for your email confirming your receipt of our Notice of Appeal. Despite your confirmation, we [LeeMon A. Tillery and Dasha B. King] were still forced out of our home, therefore cannot file our Appeal as what we expected to do immediately due to us now not having an address. We are homeless and have nowhere to live.

Dear Molly Bennett, Christopher Urso, and Jennifer Susan Kottka Colton,

Please see the picture attached confirming the fact that we [LeeMon A. Tillery and Dasha B. King] dropped off--on today, December 8, 2024--the following:

- TWO mail keys
- TWO 1-108 door keys
- TWO key fobs.

We [LeeMon A. Tillery and Dasha B. King] slid everything through the tiny opening at the very bottom of 117 East White Street's double doors (entry doors).

"Exchange at Rock Hill" owes us money and has removed us from accessing our mail; therefore, we are respectfully requesting that either "Exchange at Rock Hill" attorneys, or "Exchange at Rock Hill's" corporate manager [Christopher Urso], or "Exchange at Rock Hill's" operative Molly Bennett, or "Exchange at Rock Hill's" magistrate judge Jennifer Susan Kottka Colton contacts us immediately regarding our stolen money [from December 6, 2024 AFTER 11:50am to December 31, 2024; our Security Deposit of \$1500, -and- monies from November 27, 2023 to December 5, 2024], stolen property (our wedding rings are actually missing now, and we CAN confirm the theft), and stolen mail.

And YES, we can prove on its face: THEFT. We attempted setting up a Bond Hearing--we contacted Jennifer Susan Kottka Colton via email requesting such, yet she instead ignored us [LeeMon A. Tillery and Dasha B. King] and instructed her two inferiors (one of them actually assaulted Dasha B. King, leaving her a permanent bruise, etc.) to forcefully displace us into homelessness on Friday, December 6, 2024. The inferior who executed the assault actually made the confirmation upon multiple recordings and cameras the following: "**this order comes directly from MY BOSS Judge Colton**". She confirmed that her boss Judge Colton allowed for the thefts that have occurred. As stated, we [LeeMon A. Tillery and Dasha B. King] have evidence of the thefts occurring in real-time.
