This letter is submitted to satisfy the \$250 Filing Fee required for Appeal Request, Motion to Waive the Filing Fee and at that time Motion to Stay received by the Courts on August 23, 2024.

The results being that my Motion to Waive Fee was denied, leading to a request to extend the time to pay the \$250. It was also because on that same Friday 8/23/24 after 5pm, what I was told by a Female Officer by phone at Anderson Sheriff Office. She looked up my 24hr Writ of Ejectment by my name & case# and suggested that I follow the instructions of the 24hr Writ to remove my belongings that night before 915am the following Saturday Morning 8/24/24 or the exact date written on the Writ to ensure that my belongings are not removed and put on the side of the road if the Officer arrives and anything that I could not get out in time, try to make arrangements with the Landlord to schedule a time to get my remaining items. She was informed that I submitted an appeal & motion to stay to the South Carolina Court of Appeals, waiting for confirmation they received it.

I could not take a chance on my belongings being put on the curb. I rented a U-Haul Truck and a Storage, my female hair stylist came to help me load everything on the truck by 830am the next morning before the Sheriff arrived. Went back to clean up and on 8/25/24 went back to take photos through out the house to show all rooms were empty, appliances cleaned, mopped & vacuumed for my records. I reached out again to SC Legal to see what I should do next and they could not take my Case & did not advise me on what to do.


Please accept my apology for the delay as I never received any notification by email or snail mail.
