We granted Petitioner's petition for a writ of certiorari to review the court of appeals' decision in Weeks v. Weeks, Op. No. 2023-UP-151 (S.C. Ct. App. filed April 12, 2023). We will consider whether the court of appeals erred in (1) determining no evidence supported the probate court's decision that Respondent waived her right to an elective share of the decedent's estate and (2) finding the probate court improperly calculated the value of real property that was part of the estate.

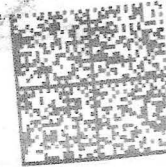
