he came to my house over A disagreement with me and my girlfriend that was not physical or anything he came to my house telling me about my household and my kids trying to make my girlfriend move out causing confusion not only did he disrespect me but he disrespected my girlfriends Dad William Salters and his wife Lawanda Salters brought him to my house with her husband present to cause chaos. He even stated his self in my rule 5 which they never brought up in court. I was home minding my business on my offday I ask Zachary to leave once I notice him getting aggressive and then he picked A Fight with me after arguing with William Salters. Zachary was drunk at the time and does drugs I couldn't put anything pass him I saw the rage in his eyes as he came for me. Not only is my life ruin but my 5 kids life is ruin too they have to be raised in A single parent household for the next 13 years.
