

Petition For Rehearing



I am asking for a rehearing on this case for the following reasons:

- (1) This case does have constitutional questions and my Pro Se Fee's far exceed 1,000 dollars. Rule 215 addresses this. There should have been oral arguments.
- (2) There is a constitutional question in the Circuit Court records where the Judge refuses to obey State Statue 30-4-10-165 to hear an FOIA case.
- (3) This case should be heard orally and a published opinion because of public importance. It is obvious the Circuit Court Judge believes he cannot hear an FOIA case . Sloan v. Sanford 357 S.C. 431,434,593 S: E. 2d 470,472 (2004) (under certain circumstances, standing may be conferred upon a party when an issue is of such importance as to require it resolution for future guidance.)
- (4) This opinion goes completely against Appellate case No. 2010-181306. This case was brought before a Judge that believes the Supreme Court is not a public body and that they do not have to answer to the citizens of S.C.
- (5) This Appellate Court has not answered any of the questions on the appeal to bring clarity to this case.
- (6) None of the reasons that this Court used were on Miss Cundari's Final Brief . I was not given a chance to ask any questions in the Circuit Court because the Judge had already concluded his verdict. If this court will take time to read Supreme Court opinion 27138 which was presented at the hearing, it asked all the questions to preserve the (Statement of Issues on Appeal.)


