I certify the 39 pg attachment has never been read in any court and is what is waiting to be read on 2/25/25 to reopen the related Conway case, #2021cp260-5635. I attach it here to show this court that this is not a frivolous attempt to Negate the sale and Stay the movement of my home. (It's still there.) My Conway case has undisputable merit to overturn not just the sale, but also the eviction. Judiciousness demands this court await the results of that case.

I bring to this court's attention sub-attachments A, K and P:

Sub-att A: My Jan. 12, 2022 bank check for \$720. That's pmt at \$360/mo for both Jan. and Feb. lot fees. (The bond fund order.)

Sub-att K: Shady Grove's confirmation of it's receipt on 1/13/22. (I paid it 1/12, the Jan. due date, at the ofc., but the mgr. was gone then and got it the next day. But that's irrelevant. Because:

Sub-att P: Shady Grove's sworn statement that I didn't pay February's fees by 2/7. (2/12 was the actual deadline per the judge's order because of the 5 day grace period inherent in So. Carolina law.) But the Feb. deadline is completely irrelevant because I paid it in January!!!!

And the magistrate refused to consider or accept this evidence at that time, and called off my Conway appeal, EX PARTE, for being non-compliant!

Because of the exigent circumstances involved here in not making this case moot, I've expedited matters for you by highlighting only the tangent points of this attachment for you to consider. I did not know how to separate and send only those pages.

I sent you on 10/24 a motion for in forma pauperus approval. That's almost 2 months and it's never been considered! And it's stopping my motions from being heard because no filing fee is being pd! I thought it had been approved because my

11/4 motion to stay was considered without pmt.. Please approve.

Also, I'm being given conflicting info on the acceptability of my proofs of service, and this is also wrongly stopping my motions from being heard. Clerk spvr Shelby Spence has told me on 11/27 and 12/2 it's ok. Yesterday, 12/12, I referenced to her my 12/3 proof of service wordage, and she said that was enough for approval and would send me amended deficiency letters with only the filing fees being mentioned. When I mentioned the 10/24 Motion for in forma pauperus, she said she was going to send everything (up) to get considered. Then abruptly hung up. I'd even sent a letter to her 11/22, with an attachment that showed she'd previously accepted this svc proof. I've received no amended deficiency letters, nor any letters saying there is no deficiency, and today is the deadline. I respectfully request approval or a reset of time. (But I don't have the time to spare before the movement.)

At the same time, I'm getting the conflicting info from the clerk assigned to my case whom Shelby is the boss of. I won't mention her by name. But also yesterday, 12/12, she said I have to send to counsel my proofs of service, not just the motions. I had to correct her.

My case may not seem very important, but it is to me. It's my home. I need to have efficiency and expedition. Please negate and Stop The Movement.

Also, I've made a motion to expunge from the public index the copies of my bill I'd sent 10/24 for in forma pauperus. It's in both the email and mail (attachments) sections.
