

**MOTION FOR EXTENSION OF TIME TO FILE INITIAL BRIEF AND
DESIGNATION OF MATTER TO BE INCLUDED IN THE RECORD ON
APPEAL**

Appellant Catherine Gadsden, by and through their undersigned attorney, hereby moves before the Court of Appeals pursuant to Rule 263(b) for an extension of time to file the Initial Brief and Designation of Matter To Be Included In the Record On Appeal. This motion is based upon the following:

1. On December 2, 2024, counsel for Appellant received Notice from the Clerk of the Court of Appeals that the within case was being remitted to the lower court. Appellant had failed to file the Initial Brief and Designation of Matter To Be Included In the Record On Appeal.

2. Counsel received the transcript of the trial on October 2, 2024 at a cost of One Thousand Two Hundred Fifteen and 00/100 (\$1,215.00).
3. In July 2024, Appellant lost his full time legal assistant of 19 years after a battle with cancer. He is left with a part-time legal assistant at two days a week. The loss of Sheena Grant shifted substantial work to Appellant's counsel. As a result, pursuit of this appeal has been delayed.
4. Counsel for Appellants believe that a grant of an extension for thirty days would be sufficient to allow him to file the Initial Brief and Designation of Matter To Be Included In the Record On Appeal.
5. Counsel further believes that the grant of this extension will not prejudice the Respondents herein.





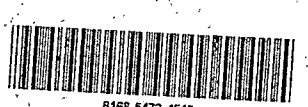
