MOTION FOR COSTS ON APPEAL**

("Respondent") hereby moves for the taxation of costs on appeal against Appellant Matthew Zetz ("Appellant") pursuant to Rule 222, SCACR, on the grounds that (1) Appellant petitioned the South Carolina Court of Appeals to reverse the circuit court's order granting Respondent's Motion for Summary; (2) the South Carolina Court of Appeals affirmed the circuit court's award of summary judgment in favor of Respondent; (3) the South Carolina Court of Appeals denied Appellant's petition for rehearing; and (4) the South Carolina Supreme Court denied Appellant's petition for writ of certiorari.
