Good afternoon,

I have received Your correspondence dated Oct 16 yesterday (Oct 24th). I had called twice today in regards to the deficiencies presented, however have not been able to speak to the person responsible for clarifying these.

The notice of appeal, proof of service of this notice together with the documents filed

on Oct 10th, have been mailed to the other parties and civil court as instructed by the court clerk prior to me even filing these papers. Hence, I am not sure what the deficiency is in that. I have mentioned that I was emailing papers, but was told only mail or in person drop off is appropriate.

As far as the proof of service is concerned for the forma pauperis, I was not instructed that I need to serve this with the fp to the other parties or the civil court. I was told on the phone by the court clerk that the forma pauperis is just for the appellate court and records.

Please advise if I need to generate and file a separate form and serve on other parties and the civil court.

Since I just received this letter yesterday, best I can do is email it at this point as I live 45+ minutes away from both courts and will definitely not make it with Friday traffic.
