“... Appellants have filed a Motion to amend their Designation of Matter, which Respondent does **not** oppose. Appellants’ Motion is hereby **granted**.”


After missing the deadline to file a RETURN, opposing Appellants’ MOTION TO AMEND AND REPLACE APPELLANTS’ DESIGNATION OF MATTER in the first place, attorney Moss belatedly filed Respondent’s MOTION TO STRIKE MATTER INCLUDED IN APPELLANTS’ AMENDED DESIGNATION OF MATTER TO BE INCLUDED IN THE RECORD ON APPEAL -- on July 8, 2013 -- six days after the Honorable Court already had granted Appellants’ MOTION to amend our DESIGNATION OF MATTER.

This sequence of events left us in doubt, as to the need to file a RETURN to Respondent’s MOTION, since it seemed that the Honorable Court already had decided this issue in our favor. 


