Plaintiff wrote a Motion to Reinstate her appeal and had amended it to Amendment to Motion to Reinstate, and didn't realize she had sent both to the court filed on September 26,2024. Plaintiff includes evidence to support her Amendment to Motion to Reinstate, that will support her case.

Plaintiff has endured hot summers and extreme cold, winters, along with her 2 cats, with having to live out of her car and a closed in Gazebo, until Darbis Briggman, Angela Mc Junkin, and William Taylor, decided to cut the power off on October 5, 2021. They interfered with Plaintiff and her insurance company in getting her home repaired therefore causing more damages. At some point it's suspected that someone went under the house and did something to the water pipes that caused the water to run causing flooding and a \$400.00 water bill.

Angela Mc Junkin began her harassment in 2012, with my Ford Conversion Van that was legal with trplate, taxes paid, and full coverage insurance, with no reason to harass Plaintiff. Maggie Brock went to Plaintiff's home with a ticket for a flat tire at 8:30 am, that happened over night, and Jeff Kandies got there with a new tire because the tire had been cut by the air valve, that ended with Plaintiff being arrested with an illegal warrant, and injured hands. Angela Mc Junkin outright lied to the committee chair, Leroy Bennett. Plaintiff exposed her for the tickets that have been given to

residents for \$1095.00 for grass 6 inches high when the ordinance says 12 inches or one foot high. In fact Plaintiff had to give the Judge a copy of the ordinance because he said he wasn't familiar with the ordinance. Case was dismissed for Plaintiff and some others.

This retaliatory actions against Plaintiff has got to stop by Angela Mc Junkin and William Taylor.

The charging Plaintiff with the property on Elderberry Circle, that belongs to Peggy Smith not Peggy Kandies was abuse of power and carelessness of Code Enforcement employee Angela Mc Junkin who has a personal vendetta against Plaintiff. Someone has to get the City of North Charleston to straighten out their code enforcement department.

SLED told Plaintiff to file a report with the police department about the incident on July 10,2023, against William Taylor with his 4th and 14th Amendments Violations and Civil Rights Violations with breaking into Plaintiff's front door and taking her belongings with no legal warrant or signed order by a judge.
