**MOTION FOR EXTENSION OF TIME FOR APPELLANTS
TO SERVE AND FILE INITIAL BRIEF AND DESIGNATION OF MATTERS TO BE

Pursuant to Rule 240, *SCACR*, Appellants, by and through undersigned counsel, Rolf M. Baghdady, respectfully move for an extension of the time in which to serve and file Appellants' Initial Brief and Designation of Matters to be included in the Record on Appeal.
