Clement J. Wells v. State Appellate Case: 2024-001921

Re: To whom it may concern in the Appellate office for the defense of Clement Jeremiah Wells case 2024-001921. I'm writing on behalf of my brief appealing sentence from the district of Florence, South Carolina General Session court seen before judge Michael Nettles, and defense public defender Bradley Parham.

The grounds of my appeal are based on ineffective counsel under negotiational plea. Defense was ineffective when having knowledge of Supreme court downward departure of prior state court matters that effect future sentencing in state court matters. Although the matters were federal revocation they affected state issues of imprisonment. I'm also appealing unconstitutional acts of imprisonment. False imprisonment of exhausted vacated sentence. Clement Jeremiah Wells v. United States 04-CR-149-TLW. Case was based on state court priors of Assault and battery, and mandatory minimums being exhausted. Case used Johnson v. United States (2015)

Note: Clement Jeremiah Wells seen in 8-9-2016 before Terry L. Wooten at the U.S. District Courthouse Matthew J Perry building 901 Richland St, Columbia S.C. 29201.

Defense Public defender Micheal Meetez exalted my case before Terry L. Wooten. Judge Wooten ordered that the Supreme court order should stand for both State and Federal grounds being the matters was based on my priors, and federal sentence. Grounds of some sort of immunity should be granted was argued and relief of prison and any sentence warranting the over sentencing time of 9 years and 9 months due to my sentence being reduced from 180 months to 93 months.

Today I'm filing under the bases of injunctive relief. When dismissal of sentence and waiver grounds are claimable.
