Good morning -

We received a notice on December 12th that the transcript was overdue and no extension had been received. We have been corresponding with the court and the court reporter since that time about the extension. We received the email chain below today, and I am concerned that our appeal is going to be dismissed and want to rectify any issues immediately. I have various other email chains regarding the transcripts that can be forwarded to the court if needed.

The court reporter requested an extension from Salley Law Firm on December 16th, even though Salley no longer needed the transcript. We have advised her numerous times that we do need the transcript, and I would have agreed to an extension if one had been requested of me. I am unsure why Salley would agree to an extension for a transcript they no longer needed.

At this time, we have still not received any extension notice although from the extension granted by Salley, it appears the court reporter has until January 14th to produce the transcript.

Please advise if there is anything that we need to provide the court with at this time in regards to this matter. I am concerned that proper procedure is not being followed by the court reporter and do not want our client to suffer any negative consequences.

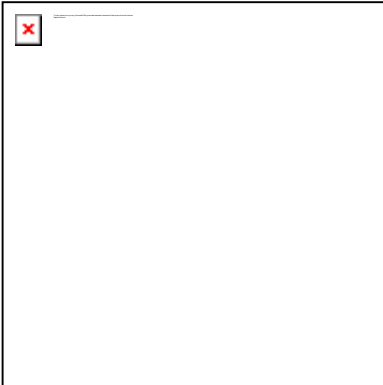

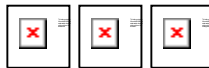
Ms. Johnson,

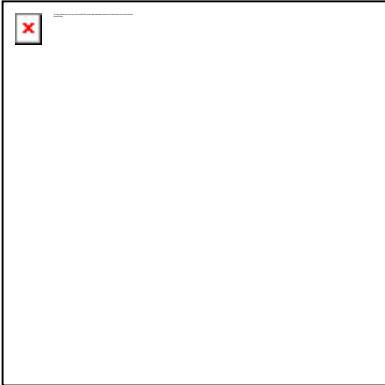

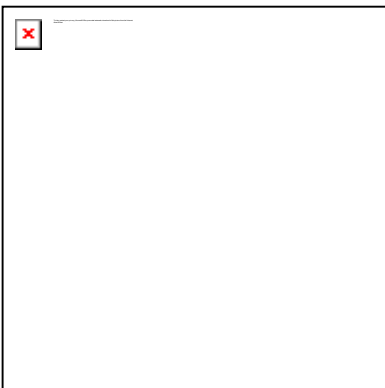
