The court has posed the question as to The Parties choice for an ADR mediator. 2 (1815), Black Diamond S. S. Corp. v. Robert Stewart & Sons, 336 U.S.  
3 386 (1949), Federal Miller Act, State Little Miller Act, United Nations  
4 Convention on Contracts for the International Sale of Goods (CISG),  
5 Department of Agriculture Rural Development Rural Housing Service  
6 v. Kirtz (Docket 22-846), and SEC Rule 10b-5. Also, defendant is the

8 Holder In Due Course regarding all claims for this case, see South  
9 Carolina S.C. Code Ann. S 36-3-302, and South Carolina Code 5 36-9-  
10 102: Defines “secured party” in South Carolina as per the UCC filed.

12 See previously served defendant UCC 1 filing number 202301237848,  
13 filed with this court document titled “AFFIDAVIT OF NOTICE [of  
14 Discharge]” with bonds attached for discharge. Discharge by this court  
15 and plaintiff is not an optional process, see 15 U.S. Code § 1 - Trusts,  
16 etc., in restraint of trade illegal; penalty. Plaintiff is an FDIC banking  
17 institution. Therefore, federal law applies.
