HOPE YOU ARE DOING WELL.

On July 25, 2024, I sent the request for a transcript to you. (This is a second transcript for a second Webex hearing.)

You wrote the email below. You stated that you rarely do Webex hearing transcriptions. You made an exception and produced the Webex Hearing Transcript of February 21, 2024, for me. (The first Webex hearing.)

You did a beautiful job.

Following your email, as you suggested, I contacted Court Administration to have the second Webex transcript assigned through their services. I encountered the problems described below, and I wrote additional letters to court administration asking for an official court reporter. As of today, I have gotten no help and no assignment to an official court reporter.

Court Administration assigned the second transcript to an online service called LegalEagles. The person who "transcribed" it seemed to have english as a foreign language and had no knowledge of terms used by the court. After repeated attempts to have the transcript they sent me produced into a complete and accurate official copy by them, I just got emails referring to linear corrections.

So, I still need an official transcript of the hearing cited below.

THE HEARING WAS IN HORRY COUNTY. IT TOOK PLACE AT THE COURT HOUSE IN CONWAY, SC, EVEN THOUGH IT WAS A "WEBEX" FORMAT.
