> I am the son of Joanne Ernesto and my wife 54 and aunt 70 live in the house. We are respectfully requesting an extension to move our belongings and vacate.

> We are hopeful that, given the circumstances, the court will take into consideration our proactive approach to resolving this issue. We are fully committed to working toward a fair resolution and will keep the court informed of any updates or changes as soon as possible.
