Counsel for appellant respectfully requests a thirty (30) day extension, in which to serve and file the Initial Brief of Appellant and Designation of Matter in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed today.
2. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Terrionna M. Hart with the Court of Appeals on January 2, 2025. Counsel filed the Brief of Petitioner in the case of State v. Andres Posso with the Supreme Court on December 23, 2024.


Counsel filed the initial brief of appellant and designation of matter in the case of State v. Tyquan Jamar Johnson with the Court of Appeals on December 20, 2024. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Marcus Tyrone Grant with the Court of Appeals on December 3, 2024. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Tyquez Brisbane v. State with the Supreme Court on November 21, 2024. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Rachel Wilcox with the Court of Appeals on November 14, 2024. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Albert Siders v. State with the Supreme Court on November 6, 2024. Counsel filed the petition for rehearing in the case of State v. Angel Ibarra with the Court of Appeals on October 31, 2024. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Travis D. Bryant with the Court of Appeals on October 21, 2024. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Carly Blumenstein v. State with the Supreme Court on October 18, 2024.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that her caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.




