Dear Chief Justice Williams,

I am writing to you regarding a response I received from Ms. Sharon Plyer Besley (Assistant Disciplinary Counsel) regarding a complaint I filed against Judge Amy McCulloch. Judge McCulloch was the presiding Judge over my deceased father's estate. Because of the injustice I experienced in the probate court, with Judge Belton and the clerks of the court, I filed a complaint with the ODC after being forced to mediate and an unjust decision was rendered by Judge Belton, who should have recused herself. I believed the decision would not be excepted under the circumstances and another Judge would make the decision regarding my father's estate. After being assaulted by my uncle and calling 911, I stated I was going to protest against the probate court and the injustices experienced there, as well as the police for targeting and ticketing me and civil/ human rights violations. After which I was involuntarily committed to the psychiatric ward of the VA Hospital for a 24- hour mental evaluation, ordered by Judge Amy McCulloch. (Please review my complaint against her). I have been seeking justice ever since.

Ms. Plyer Besley stated that the case against Judge McCulloch does not fall under the rules of the court therefore, judge McCulloch will not be held accountable for her unethical behavior. She also stated that the court does not seek to get a judge to do something a person wants done. However, this is not the case, I'm seeking to hold Judge Mcculloch accountable for her unethical behavior, just like I sought and seek to hold all other parties accountable for their actions, (the police and the VA). What they did turned my life upside down. I was appalled by the decision rendered by Ms. Besley.

Judge McCulloch willingly and knowingly signed an order to commit me to a 24-Hour mental evaluation at the VA hospital psychiatric ward which turned into a 21-Day nightmare. She did this in retaliation for filing complaints against Judge Belton and the probate court, and to make me look mentally incompetent and incapable of handling my father's estate not to mention, seeking to give my sister an opportunity to gain power of attorney over my affairs which she attempted to do while I was

hospitalized. I had also been told by my sister that the police came to her house prior to this incident and attempted to get her to commit me to the psychiatric ward claiming I was telling lies on them when filing complaints against them to their superiors regarding inaccurate reporting, their human rights violations, and their failure to investigate the criminal acts I was subjected to, just to name a few.

My character was defamed, I was given inaccurate medical diagnoses and forced medications that I should never have been prescribed.

Judge McCulloch was being allowed to make decisions regarding my father's estate, yet I believed she would not and could not be unbiased due to the fact that I protested against her, Judge Belton, and the probate court outside the courthouse.

As my complaint stated, while I have forgiven Judge McCulloch for what she's done, she must be held accountable, along with all the other parties involved.

Please review my complaint and investigate Judge Amy McCullouch accordingly.

Judge Belton was investigated and Judge McCulloch should be as well and held accountable for her actions by whatever disciplinary actions you use.
