I Randall Loyis Simpson am writing in respect and bringing forth all the legal documents I have filed with the courts trying to find and locate the Sentenced Time Appeal I filed with the courts and mailed from Florence County Detention Center on June 26, 2023 on the morning of my transfer to South Carolina Department of Corrections.

I mailed the letter and Appeal to The South Carolina Court of Appeals, because I went to the mailroom and had my envelope weighed, I had to pay 0.63¢ in addition to the postage to have the legal documents mailed out to the Court of Appeals. They was also training a new mailroom personel body for the mailroom position at this time. She handled my legal documents unprofessionally, while the original mailroom body explained to her how to scan my mail, weight my mail for extra postage and then asked her trainer where to put it. I believe upon information and belief my Appeal never got mailed out of the Kirkland Corr. Inst. mailroom. I also have legal documents where I wrote to Warden Wallace concerning my misplaced legal mail in Kirkland Corr. Inst. mailroom.

I was transfered to Turbeville Corr. Inst. were I found out my mail never made it to The Court of Appeals. I wrote the Warden, Warden Wallace at Kirkland Corr. Inst. and explained in detail. As you see, I recieved a copy from D. Smith, Postal Director "KCI" and they asure it was mailed out, when it was not, cause the Courts never recieved it.

I Randall Loyis Simpson am bringing forth the same and original copy of filed Appeal that was filed with Florence County Complex, Clerk of Courts Office, and the mistake by me, whereas, I mailed one copy to the wrong courts, United States District Court, 901 Richland St., Columbia, S.C. 29201.

Whereas, I had to re-write the Sentenced Time Appeal from the original rough-draft dated June 23, 2023. Which I am sending with Sentenced Time Appeal to prove the Appeal was filed within (it's) ten (10) days and all legal document rough-drafts wrote and mailed to the courts trying to locate and find my Sentenced Time Appeal.

Around the first week of November 2023, I recieved the filed Appeal from Florence County, Clerk of Courts Office. It was filed Dated October 30, 2023. Which this Sentenced Time Appeal was wrote on June 23, 2023 and mailed in on June 26, 2023 on my day of transfer to South Carolina Department of Corrections.

Before I recieved the file dated Appeal from Florence County, Clerk of Courts Office, I recieved a legal letter back from The Supreme Court, Clerks' Office

stating that they contacted Florence County, Clerks Office and they stated they had no records of a filed Appeal with there Office. This letter from The Supreme Court, Clerk of Courts Office was dated October 17, 2023 and the envelope that the letter came in was post marked October 17, 2023, which I'm sending a copy of the post marked envelope because the letter I mailed with the October 30, 2023 filed Appeal was mailed to the Court of Appeals from Kirkland Corr. Inst. mailroom, but never made to where it was addressed too.

Again, all of a sudden out of nowhere the October 30, 2023 filed Appeal was mailed to me at Kirkland Corr. Inst. from Florence County, Clerk of Courts Office between November 1st and the 4th. When I got this Appeal I put the Appeal in an envelope with the legal letter dated October 17, 2023 from The Supreme Court and mailed it to The Court of Appeals. I sent the letter to prove and show that when The Supreme Court contacted Florence County, Clerk of Courts Office they lied. Upon information and belief, I believe Florence County got scared and brought the Appeal from under the rug and mailed it to me, due to passed legal issues I have brought forth on Public Officials in Florence County.

What I have brought forth is all written legal documents I have filed trying to track down and locate my Sentenced Time Appeal I have filed, which I still have not been able to do, but I'm bringing forth all this as proof to prove my Sentenced Time Appeal was filed on time and before the ten (10) days of expiration was up.

I'm sending in the re-wrote original Sentenced Appeal, because we can not find my other ones. So I am also writing and asking if you would please take in all this and please allow me to continue to file my Sentenced Time Appeal with your Courts. - On June 22, 2022 Jay John Ervin III took me to court and tried to get me to plea to charges Burglary 1st CDV 1st, Possession Of Stolen Vehical, and Possession of Cocaine. Jay John Ervin III try to force me into pleading to these charges by manipulating me by saying this is a good Judge and you can get these charges put behind you. I refused and did not plea cause I am innocent. to above charges.

- On June 22, 2022 on the same day as above, Jay John Ervin III refused to lift my Bench Warrant by saying the Judge is not going to lift your Bench Warrant and I'm not going to ask the Judge Seals to do so. I cut my Probono Lawyer off and spoke up in Court to Judge Seals. I explained the situation that occurred. I also have File Dated Documents Filed through the Clerk of Court proving this. When I explained this to Judge Seals Judge Seals lifted my Bench Warrant and told Jay John Ervin III to Contact the Bondsman and have me released.

- On June 22, 2022 on the same day as above, Jay John Ervin III did not and would ^{not} file my Formal Order with the Clerk Of Courts Office to have me released, because I ^{went} over his head and had my Bench Warrant lifted. ^{before Judge Seals} Jay John Ervin III made me sit in Jail over a month before he filed the Formal Order for my release. I had to write Jay John Ervin III and threaten to Refer him to the Office Of Disciplinary Counsel before he filed the Formal Order and had me released. I was released on July 26, 2022.

- On July 27, 2022 day after my release from Florence Detention Center, Jay John Ervin III brought me before the Courts. ^{I told him I wanted to go to Trial} Jay John Ervin III begged and ^{I told Jay J. Ervin I wanted to go to} tried to force me again to plea to the charges said above. When I got in front of Judge Deberry I told Judge Deberry I wanted to go to Trial on all pending charges and I was not guilty of any charges pending against me. Therefore Judge Deberry granted my request.

- On June 10 2023 I wrote Jay John Ervin III. I told Jay John Ervin III I wanted to get this all behind me.
- On June 21, 2023 while at Florence County General Sessions Court I spoke with Jay John Ervin III. The deal for me to plea to was, plea guilty to the Possession of ^{stolen} Vehicle valued less than \$2000, ^{includes} all other charges dropped ~~including~~ ^{that} I was going to trial on, run-concurrent with Probation. He said I only have 2 years left on Probation with 600 days credit and you have never been in any trouble since on Probation. ~~You will be a turn around.~~ I said I still have 323 ^{days} credit on all ~~pending~~ ^{charges}. So 600 days and 323 days which is 923 days credit. I told him about my wife, my job, and that my truck was in the Florence impound with over \$10,000.00 worth of my tools. ^{in it} I'm a Mobile Mechanic, Jay John Ervin III said tell your wife to go get your tools, hung the phone up and walked out the glass holding Cell booth.
- On June 21, 2023 Prosecutor Daniell read before the Courts and charged me with a charge that I was going to Trial for, ~~whereas~~, Jay John Ervin III advised me this charge was dropped or I would not have plead guilty to any charges. I had agreed to plea to the Magistrate Misdemeanor charge. 30 day charge.

- On June 21, 2023, there was a Probation Agent that was not my Agent. This Probation Agent has been in the Court room every time ballancing full revocation to the Judge before the Courts. This Agent is not my Probation Agent. My Probation Agent is Agent Charles Watson. My last home visit Agent Charles Watson told me I was doing good and the only thing wrong I was behind \$200.00 maybe a little more. This Probation Agent stood before the Honorable Court and lied saying I have done nothing I was suppose too, while on Probation. Only trouble I was violated for a 2021 Traffic Ticket and sentenced by Judge Deberry 90 days. Whereas, Agent Charles Watson was not present before the Courts to recommend any violations and/or Stipulations on my Probation. at anytime I have been before the Judge. Why is that?

- On June 21 2023 while in Court this Probation Agent went and spoke with someone in the Court roomy pears. This lady stood up and said because of me her husband was dead. Whereas I am on Probation for alleged charges from 2019. Whereas Mr. Mullins was divorced a wife and lived alone for 30 or 40 years at 950 South Cashua Dr. ^{address} Mrs Mullins died in a Nursing home 2 years later after these alleged ^{full fled} charges were brought against me. Mr. Mullins died of Dementia, Covid, and due to a leg being amputated while being in the Nursing home. Whereas she lied before the Honorable Court, Whereas, upon information and belief I believe this woman was coerced by this Probation Agent, to lie before the Honorable Court

know what is happening. Most have not learned that grief comes and goes and takes much longer than most people expect. We need to realize that this is the way grief works itself out and trust that the process, difficult as it is, is helping us work towards reconciliation.

10. Effective grief work is not done alone

Society has unrealistic expectations about mourning and often responds inappropriately. Most people do not understand what is normal in grief, expecting us to get over it quickly and expressing these expectations in a way that seems less than sensitive. Many people mistakenly believe that grief is so personal we want to keep it to ourselves. People mean well, but they are not being helpful. Sometimes when people are using cliches or expressing unrealistic expectations we feel like shutting ourselves away. Often they feel uncomfortable with our grief and so, shortly after the funeral is over, the person or the loss is not mentioned. There sometimes seems to be a conspiracy of silence. People are afraid to say or do the wrong thing so they say and do nothing which is possibly the worst thing. Grieving people need to talk. Not everyone will be willing or even able to respond to you. In fairness, not everyone can. Accept that and try to find a support group or a counsellor who can help. Or talk to someone who has been through a similar experience. Grief is about coping with the loss of a relationship and often in a helping relationship, relief can be found.
