I Sent a 2page letter on °11/30 and I also sent 1page request of documents filed dated for °12/10 and a 1page Notice of Appeal Amend remittur dated °12/10 and also 3 pages of Appeal for Double Jepordy Probate and motions all was in the same envelope ~~except~~^{sw} except the 2page letter on °11/30 it was sent Seperatly on 12/4 when I ~~was~~^{sw} returned to Camille-Graham I was kidnapped and taken unwarranted from PRISON on 10/28/24 I was taken to Lancaster Hospital and subjected to false imprisonment, Hostage Holding, unwarranted confinement and Double Jepordy Bryan Stirling IS embezzling government money that should be going to the prison and running an illegal mental Facility subjecting inmates to Double Jepordy and Scott Lewis (under director) and Bryan Stirling (Director) had me kidnapped 10/28 and stole my legal mail and personal mail and held me Hostage until 12/4 I was subjected to Double Jepordy because they are conducting illegal probate Hearings and Not Absolutely discharging inmates cases and Forcing inmates to take meds and saying inmates are incompent and Admitting them on an emegency Admission instead of a Judical Admission which IS warranted

they are forcing inmates to go there Bryan Stirling made a contract with Lancaster Hospital to embezzle money from the State of South Carolina According to MyChart account for 12 days at Marsha Pickens was \$15,000 charged to me it was 9 people there that is over 145,000 dollars every 12 days I was subjected to Double Jeopardy 11/15/24 at Probate Court Richland County SC the order was Filed 4:32:53 PM

Case# 2024-MI40-02360 the Applicant is Prentiss Myers this is the state of South Carolina County of Richland the Guardian ad Litem was Gregory Eugene Parker, Jr as court Appointed attorney The judge was Nia Behling Associate Judge of Probate court Richland County probate this took place Nov 15, 2024 via telescreen so the entire Hearing is recorded they wouldn't Allow me to absolute Discharge my criminal case to probate court as I requested and they stole my Appeals and my legal mail to the courts Scott Lewis Never delivered the mail while I was held hostage at Lancaster Hospital 10/28/24 - 12/4/24 kidnapped and False imprisoned me and subjected me to double jeopardy My original Criminal case was Appellate Case No. 2024-001268 which the South Carolina Court of Appeals used the incorrect Remedy Yall remitted the case back to District court And the order dated Oct 29 stated that Appeals court had Jurisdiction from Aug 1st - Oct 29 meaning Judge Perry Gravely acted outside of his Jurisdiction Aug 19 - Sept 26 and created a fraudulent Sentencing Sheet

Affirm the Jurisdiction of the Appeals Court being Aug 1st -
Oct 29th in accordance to the order both District and
Appellate cannot have jurisdiction at the same time and
this was a interdictory meaning durinning / in the middle
of trial and BEFORE sentencing Not a post conviction
Judge Perry Gravely Committed Perjury and created a
Sentencing Sheet between Aug 19 - Sept 26 and said it
was created 7/31 which is perjury he acted outside
his judicial capacity on 7/31 the sentence was

I have Not been legally sentenced and I was kidnapped and taken outside of Jurisdiction as a retaliation Act I am the target of a Racially motivated Hate crime I would like yall to Dismiss the Probate Hearing order It is Double Jeopardy I am Appealing that order dated Nov 15 2024 and showing the Court that I am being subjected to Double Jeopardy unlawfully by being punished through Probate and Criminal Court and My Criminal Case I didn't get due process the Judge Acting outside His Jurisdiction is illegal and I ~~Appealed~~^{sw} Appealed yall order Oct 29 and showed good cause for a time extension longer than 30 days Due to being taken Unwarrant from 10/28/24 - 12/4/24 and public officials stole my legal Mail Appeals dated for 11/8 I did Appeal My case to the Supreme Court of Appeals in case Citation Re Sawyer, 124 US 200 (1888) If a Judge does not fully comply with the constitution then his orders are void in re Sawyer, 124 U.S. 200 (1888) he/she is without Jurisdiction and he/she has engaged in an act or Acts of treason And Judge Perry Gravely Acted outside of his Jurisdiction and created a fraudulent Sentencing Sheet and violated my due process by sending me to prison outside his judicial capacity which is against the constitution and his oath.
