

Failure To Stop For A Blue Light

Personally appeared before me, a magistrate of this County, one, J. Aratan who first being duly sworn, deposes and says that

MICHAEL TYRUS JETE

did within this County and State on the 30th of December, 2023 violate the criminal laws of the State of South Carolina in the following particulars:

DESCRIPTION OF OFFENSE
FAILURE TO STOP FOR BLUE LIGHTS AND SIRENS 2nd OFFENSE
56-05-0750 (B)(2)

The affiant states there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on the 30th, December 2023, at approximately 1:23 A.M., while at 3291 Ashley Phosphate Road, which is located in the City of North Charleston, County of Charleston, State of South Carolina, the Defendant, one MICHAEL TYRUS JETER, did commit the offense of FAILURE TO STOP FOR BLUE LIGHTS AND SIRENS 2nd OFFENSE, in violation of section 56-05-0750(B)(2) of the South Carolina Code of Laws of 1976, in that the Defendant did willfully and unlawfully accelerate in a vehicle and refused to stop once blue lights were activated in an attempt to flee from law enforcement.

Facts to establish the aforesaid are that Ptl. Aratan initiated a traffic stop for a tinted license plate cover on a Red Jaguar Bearing SC Tag (#VDNS85), with the defendant initially stopping in the 7/11 gas station parking lot, located at 3291 Ashley Phosphate Road. While running the defendants driver's license information, the defendant took off at a high rate of speed from the traffic stop. Officers then proceeded to pursue the defendant with emergency equipment activated. The defendant then proceeded to drive recklessly in an attempt to evade officers. The defendant also has a prior Failure to Stop for Blue Lights conviction on 08/25/2017.

Ptl. Aratan, and PFC Perry are witnesses to prove the same. All this done against the law, peace and dignity of the City of North Charleston and the state of South Carolina.
