We are in receipt of the Court's letter dated January 16, 2025. Respondents' counsel filed a Motion for Appellants to Amend Record on Appeal on November 5, 2024, claiming that there were items missing.

Upon review of the Record, those items were already included. The December 7, 2022, S.C. Court of Appeals Decision in Favor of Defendants-Reversed Circuit Court's Order of Summary Judgment and Remanded to Circuit Court-Appellate Case No. 2020-001104 is on R. 41.
