

Appellant, Courdell D. Loadholt, appeals the order of the Honorable Eugene C. Griffith, Jr., signed May 22, 2023, denying his claim of immunity under the Protection of Persons and Property Act. Appellant further appeals his conviction and sentence, and the ruling of the trial court on his motion for new trial based on alleged juror misconduct. 
