NOTICE OF APPEAL

The Defendant respectfully appeals the Order of the Honorable Judge Thomas McGee Denying the Appellant’s Motion to Alter and Amend the underlying Dismissal of Tricia Flowers and Flowers Consulting, LLC that was entered on December 27, 2024 and received on December 30, 2024 via review of the records. The underlying Order that dismissed Defendants Tricia Flowers and Flowers Consulting, LLC was entered on November 5, 2024 and discovered on November 8, 2024 via a review of records. This appeal is an appeal of the last Defendants in the case and was timely filed within 30 days of viewing the Denial of the Motion to Alter and Amend.

The defendant respectfully appeals the Interlocutory Orders of the Honorable Jocelyn Newman Denying the Motion to Alter and Amend entered August 14, 2024 and the underlying Order entered July 14, 2023 that Denied the plaintiff's Motion for Continuance; Denied Plaintiff's Motion for entry of Default against Defendants Tricia Flowers and Flowers Consulting, LLC; Granted Tricia Flowers and Flowers Consulting, LLC motion to set aside the default; and Denied the Plaintiff's Motion to Dismiss Counterclaims.

The Defendant respectfully appeals the Interlocutory Orders of the Honorable Judge Coble dismissing the *lis pendens* on the properties, Denial of the Motion for Sanctions (at this time) Granting Defendant Tricia Flowers Motion for Continuance and denying the Plaintiff's Motion to Amend the Complaint.




