I AM IN RECEIPT OF YOUR LETTER DATED JANUARY 13TH, 2025 AS OF 01/17/2025 APPROXIMATELY 10:00 PM. UNFORTUNATELY FOR YOU, YOUR LETTER INCLUDES SEVERAL CLAIMS WHICH ARE FACTUALLY INCORRECT. TO MAKE SUCH CLAIMS, YOU MAY HAVE CRIMINALLY IMPLICATED YOURSELF IN VIOLATION OF SC STATE AND U.S FEDERAL LAWS.

IN YOUR LETTER, YOU HAVE USED (•) POINTS RATHER THAN NUMERICAL OR ALPHABETICAL IDENTIFICATION. GIVEN NO WAY OF PROPER REFERENCE TO YOUR STATEMENTS, I HAVE NO CHOICE BUT TO ADDRESS THEM AS #S 1-5 AS PRESENTED IN YOUR LETTER.

NUMBER 1 (•); I HAVE ALREADY ATTENDED A COURT HEARING IN THE GREENVILLE COUNTY COURTHOUSE AND HEARD BY JUDGE SIMMONS THE MASTER IN EQUITY FOR GREENVILLE COUNTY ON DECEMBER 11TH 2024. THIS HEARING WAS ATTENDED BY CBE'L COUNSEL BROOKE FOWLER AND HIS ASSISTANT CATHERINE THOMPSON. REQUIRING ME TO PROVE ANY OTHER STATEMENT IS TO PLACE ME INTO DOUBLE SEPARDY. I AM AN INMATE BEING DEPRIVED OF MY RIGHTS TO ACT PRO-SE, I AM AN INMATE WHO

IS BEING HELD AS I WRITE THIS IN A CELL KNOWN AS CELL 3 ON FLOOR 4A OF THE GREENVILLE COUNTY DETENTION CENTER. I, ALONG WITH 7-8 OTHER INMATES ARE CONFINED 24-30 HOURS AT A TIME WITHOUT THE ABILITY TO ACCESS THE LAW LIBRARY MUCH LESS ADEQUATE PROVISIONS TO ACT PRO-SE THEREBY MAKING YOUR FIRST (c) STATEMENT NULL AND VOID

NUMBER 2 (c); ACCORDING TO 28 U.S.C., I AM NOT REQUIRED TO PAY THE FILING FEE AS A PRISONER. FURTHERMORE, YOUR STATEMENT MAY IMPLICATE YOU ~~PER~~ AS BEING PERSONALLY FINANCIALLY LIABLE TO ME UNDER CIVIL CONSPIRACY PER A US SUPREME COURT PRECEDENT. WITHOUT ACCESS TO A LAW LIBRARY, I CAN ONLY REFER YOU TO LOOK UP CIVIL CONSPIRACY AS DEFINED BY THE BOUVIER LAW DICTIONARY. I HAVE IN MY NOTES AMERICAN HERITAGE BANK, INC V. McNAUGHTON, 879 N.E. 2d 110. THIS US SUPREME COURT RULING MAY CERTAINLY HAVE PUT YOU INTO AN EGREGIOUS VIOLATION OF LAW. YOU MAY WANT TO SEEK LEGAL DEFENSE AS YOU STUDY THIS. MY ATTESTMENT TO FACTS, AS WELL AS MY SUBMITTAL OF A WRITTEN FORM AO 240 COMITS ME FROM BEING REQUIRED TO PAY THE 250⁰⁰ FILING FEE. FURTHERMORE, AS A PRISONER, AND EFFECTIVE BY ORDER OF THE UNITED STATES DISTRICT COURT FOR THE DISTRICT OF SOUTH CAROLINA, SEE B. GENERAL INFORMATION ABOUT THE FINANCIAL CERTIFICATE, I DO NOT HAVE TO PAY THE 250⁰⁰. NOT ONLY THAT, FORM AO2 CLEARLY

BUILDING AND LOAN. MY STATEMENTS OF FACT CAN BE FOUND IN PALER UNDER C/A No. 20-03558-HB. YOUR LETTER, AS CHIEF DEPUTY CLERK, ONCE AGAIN PUTS YOU POTENTIALLY FINANCIALLY LIABLE TO ME, TO VIOLATE A FEDERAL BANKRUPTCY JUDGES ORDERS IS A FEDERAL FELONY. A FEDERAL FELONY COULD UPON CONVICTION, PLACE YOU INTO THE FEDERAL PRISON SYSTEM AS WELL AS MAKE THE STATE OF SOUTH CAROLINA LIABLE FOR ACTUAL, PUNITIVE AND COMPENSATORY DAMAGES. GIVEN ALL OF THESE FACTS, YOUR REQUEST LISTED UNDER # 3(0) IN YOUR LETTER IS NOT ONLY FALSE, INACCURATE, MISLEADING, IT IS POTENTIALLY CRIMINAL, I DECLARE AS FACT THAT # 3(0) IS DEVOID OF ENFORCEMENT BY LAW.

4(0) I AM UNSURE OF WHY YOU WOULD MAKE SUCH A STATEMENT. NOT ONLY DID I APPEAR TO JUDGE SIMMONS IN PERSON, I INCLUDED IN MY LETTER TO THE SOUTH CAROLINA COURT OF APPEALS MY DECLARATION OF APPEAL TO THE MASTER IN EQUITY OF GREENVILLE COUNTY JUDGE SIMMONS. JUDGE SIMMONS HAS RESPONDED TO MY APPEAL IN A LETTER HE SIGNED DATED DECEMBER 18TH 2024. JUDGE SIMMONS WROTE; "MR HOLTZCLAW, I HAVE RECEIVED YOUR LETTER DATED 11/28/2024. I AM NOT CERTAIN WHAT YOU ARE REQUESTING. BUT, IT SEEMS TO BE ARISING OUT OF BANKRUPTCY COURT AND FAMILY COURT ISSUES AND ORDERS. IN THAT I DO NOT HAVE JURISDICTION OVER THOSE COURTS AND ISSUES. I AM UNABLE TO BE OF ANY ASSISTANCE. I AM DIRECTING

THAT YOUR LETTER NOTED ABOVE BE FILED WITH THE GREENVILLE COUNTY CLERK OF COURT IN 2024-CP-23-05481." AND THEN SIGNED BY JUDGE CHARLES B. SIMMONS JR.

FIRST OF ALL, I QUESTION JUDGE SIMMONS MENTAL CLARITY IN DATING HIS RESPONSE DEC. 18 2024 TO A LETTER THAT HE DID NOT RECEIVE UNTIL DEC 28th 2024, STRANGE.

EQUALLY, I QUESTION YOUR MENTAL CLARITY MRS HARRISON, YOU COULDN'T HAVE WRITTEN ME YOUR LETTER HAD YOU NOT HAVE ALREADY RECEIVED NOTIFICATION OF MY APPEAL. I HAVE NO DESIRE TO MAKE FALSE CLAIMS NOR ACCUSATIONS, YET YOUR STATEMENT IN #4(*) IN YOUR LETTER DATED JANUARY 13th 2025 COLLAPSES UPON ITS OWN LACK OF INTELLIGENCE OR LAWFUL FACTS. BASED ON YOUR OWN WORDS, IN WRITING, YOU HAVE MADE #4(*) NULL AND VOID.

#5(*) I REFER TO MY STATEMENTS OF FACTS AS OUTLINED IN #3(*). YOU, NOR THE SOUTH CAROLINA COURT OF APPEALS CAN LAWFULLY VIOLATE MY RIGHTS UNDER DUE PROCESS WHEN IT IS THE COURTS WHO ARE RESPONSIBLE FOR ENFORCEMENT OF STATE AND FEDERAL LAWS. YOUR STATEMENT LISTED IN #5(*) IS A CLEAR VIOLATION OF MY SC. AND U.S. CONSTITUTIONAL RIGHTS. YOUR STATEMENT UNDER #5(*) COLLAPSES UPON ITSELF THEREBY MAKING #5(*) NULL AND VOID AND HAVING NO LEGAL MERIT(S) WHATSOEVER.

MRS. HARRISON, I FIND YOUR LETTER TO BE UNENFORCEABLE.

I FIND YOUR LETTER TO BE OFFENSIVE TO THE RULE OF LAW.

I FIND YOUR LETTER TO BE A COMPLETE WASTE OF TIME AND MONEY ON BEHALF OF MYSELF AND ALL CITIZENS OF THE STATE OF SOUTH CAROLINA. I AM ASHAMED OF APPARENT LACK OF INTEREST OR EVEN COMMON SENSE.

PLEASE COPY AND FORWARD MY RESPONSE AT A MINIMUM TO BROOK FOWLER. 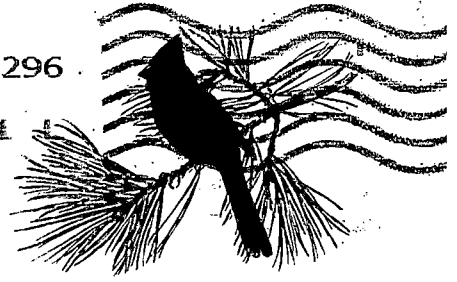

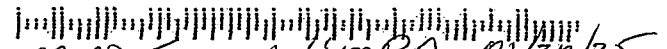
