**REPLY TO RETURN TO
MOTION TO REINSTATE APPEAL**

Appellants submit the following in reply to the return and opposition to the Motion to Reinstate Appeal.

On January 24, 2025, Judge Gravely issued an Order, *sua sponte*, staying the proceedings in each of the trial court matters during the pendency of Appellant’s Petition to the Chief Justice of the South Carolina Supreme Court. A copy of the Orders are attached hereto as **Exhibit A**. These Orders come ahead of a motions hearing in the trial court matters scheduled for later in February, demonstrating the trial court’s recognition of the efficacy of the Petition as affecting the trial court proceedings. This further supports Appellants’ assertion that the orders from which this appeal originated should not have been issued while the Petition was pending.

Accordingly, Appellants respectfully request this Court reinstate the previously dismissed appeals for further determination of the appropriateness of Judge Salvini’s ruling during the pendency of Appellants’ Petition to the Chief Justice of the South Carolina Supreme Court.



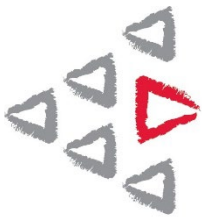
