
Shandah Jo Silvia, appeals her conviction and sentence on the above indictments. The sentence was imposed by the Honorable Robert Hood on January 9, 2025.



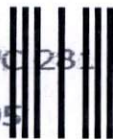
