

NOTICE OF APPEAL

Londell Lashun Alston appeals his conviction and sentence in this case. The sentence was imposed by the Honorable R. Keith Kelly on January 23, 2025. The Appellant was found guilty of Trafficking in Heroin, Morphine, etc., 28 g or more (§ 44-53-0370(e)(3)(c)), Trafficking in Fentanyl, 28 g or more (§ 44-53-0370(e)(9)), and Trafficking in Methamphetamines or Cocaine Base, 200 g or more, but less than 400 g (§ 44-53-0375(C)(4)). Appellant received a sentence of twenty-five (25) years for Trafficking in Methamphetamines or Cocaine Base, 200 g or more, but less than 400 g and forty (40) years and \$200,000 fine for Trafficking in Heroin, Morphine, etc., 28 g or more and Trafficking in Fentanyl, 28 g or more. Appellant's sentences run concurrent. Londell Lashun Alston was given credit for time served beginning on July 14, 2023.
