DETAILED STATEMENT OF INVESTIGATION: ON DECEMBER 6, 2018 AT APPROXIMATELY 1649 HOURS LT LINDER WAS DISPATCHED TO A RESIDENCE IN REFERENCE TO A BURGLARY THAT WAS CALLED IN THROUGH 911. THE CALLER ADVISED DISPATCH THAT SHE LEFT THE RESIDENCE BUT WOULD BE HEADED BACK TO THE RESIDENCE FROM CVS. LT LINDER AND CHIEF GRIMES ARRIVED ON SCENE AND MET WITH DEBBIE JEFFCOAT AND HER DAUGHTER [REDACTED] WHO ADVISED THAT [REDACTED] ARRIVED HOME FROM WORK AND FOUND THEIR BACK DOOR OPEN. [REDACTED] ADVISED THAT SHE FELT SOMETHING WASN'T RIGHT SO SHE LEFT THE RESIDENCE CALLED 911 AND WENT TO HER MOTHER'S JOB. MRS. JEFFCOAT STATED THAT THEY HAVE CAMERA FOOTAGE OF THE SUSPECT ENTERING AND LEAVING THEIR RESIDENCE WITH THEIR BLACK PHILIPS 65 INCH SMART TV. LINDER VIEWED THE FOOTAGE WHERE SHE OBSERVED WHAT APPEARED TO BE A BLACK MALE WEARING A BLACK KNITTED HAT, LIGHT COLORED JEANS, WHITE SNEAKERS, BURGANDY COLORED (DARK COLOR) SHORT SLEEVE SHIRT WITH A WHITE SHORT SLEEVE SHIRT UNDERNEATH. THE SUSPECT FORCED HIS WAY INTO THE BACK DOOR OF THE RESIDENCE AND EXITED CARRYING A LARGE BACK FLATSCREEN TV, HOME OWNER ALSO NOTICED THAT THEIR AMAZON FIRE STICK WAS MISSING.

LINDER DUSTED FOR LATENT PRINTS AND WAS ABLE TO COLLECT ONE POSSIBLE PRINT FROM THE OUTSIDE OF THE BACK DOOR DOOR KNOB. THIS PRINT WILL BE SUBMITTED TO ORANGEBURG PUBLIC SAFETY EVIDENCE FOR PROCESSING. LINDER ALSO COLLECTED A LARGE JAR THAT WAS USED TO SAVE COINS THAT WAS EMPTIED BY AN UNKNOWN SUBJECT(S) FROM A PREVIOUS BURGLARY, THIS JAR WILL ALSO BE SUBMITTED TO ORANGEBURG PUBLIC SAFETY FOR PROCESSING.

MRS. JEFFCOAT BELIEVE THAT THE SUBJECT IS A RANDY JEFFCOAT FROM WHAT SHE HEARD, CHESTNUT IS POSSIBLY THE SUBJECT WHOM SHOT HER DOG ON THE MORNING OF SEPTEMBER 21, 2018. JEFFCOAT ADVISED SHE DO NOT KNOW CHESTNUT BUT THAT IS THE NAME SHE IS HEARING.

MR. JEFFCOAT ARRIVED HOME AND WAS ABLE TO PROVIDE LINDER WITH THE SERIAL NUMBER FOR THEIR TV WHICH WAS 0690958525059, THIS SERIAL NUMBER WILL BE ENTERED INTO NCIC AS STOLEN.
