

NOTICE OF APPEAL

Tommy Wayne Bost, Jr. appeals his guilty pleas and the sentence imposed by the Honorable William McKinnon. On April 16, 2024 the appellant pled guilty to two counts of Unlawful Neglect of a Child. Sentencing was deferred until May 13, 2024, to which he was to turn himself in. After he did not show a bench warrant was issued for his arrest. On May 17, 2024 he was taken into custody until his sentencing. Sentencing was heard on February 5, 2025. The Appellant received a Three (3) year sentence. The sentences are to run concurrent with credit for time served of 2 days.
