This request for an Appeal is for Florence County Bond Court Judge Seals, after my bond was denied, and I was ordered to complete a Physic evaluation because of false testimony by the alleged victims Mr. Chavez McCall, and Mr. Dominic Owens without them submitting any discovery of their allegations 6 months into my incarceration. I was also denied my right for waiver of Counsel which I filed with the Florence County Clerk of Court on November, 4th 2024. I attempted to address that motion at this bond hearing that was held on February, 3rd, 2025 which was denied. Attorney William Schwab stopped me in the middle of my arguement from addressing

that motion. Judge Seals never acknowledged my motion to waive my counsel even though it was already filed in advanced. Judge Seals then ordered me to complete a Physic evaluation so I wouldn't be able to represent myself at the hearing, which is delaying my case even more. He made his decision based off of hearsay, and gossip and not facts, or hard evidence. I asked for my witness Ms. Amy Robinson to be subpoenaed to that hearing as well but she was not subpoenaed. She is my witness that I showed up to several court hearings, which one of the alleged victims Mr. Chavez McCall did not show up to with The Honorable Judge Peter Becker before I was even placed in Custody. She is also a witness that alleged victim Chavez McCall did not submit any evidence for his allegations, and denied any involment with my arrest in regards to his responce to my Federal lawsuit against him. I ask the court to grant this appeal, and rehear my bond hearing, and the order for me to complete a Physic evaluation with the proper witnesses present. I also ask the appeal court to rehear my motion for my

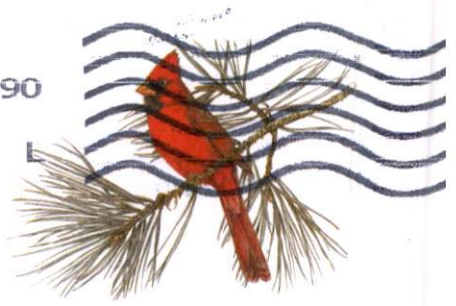
right to waiver of Counsel as I submitted several reasons for why I want to relieve Mr. William Schwab. I asked Mr. Schwab to refile several motions that I had already filed with the clerk of court that he refused to refile. I also asked him to subpoena a witness to my bond hearing which he did not, but it would of benefited us at the bond hearing. The defense also asked Attorney William Schwab to refile his request for a preliminary hearing back in October, 2024 which he never did. Last but not least after Judge Seals refused to acknowledge my motion for waiver of Counsel the defense instructed Mr. Schwab to submit a document into discovery at the bond hearing which he also refused to do. Instead of giving the document to the bailiff to submit into evidence as an exhibit he just asked the judge if he will like to see the document, and of course he declined to look at it. The defense ask the Courts to humbly, and respectfully grant this appeal. Thank you #Godbless
