PETITIONER'S MOTION FOR TAXATION OF COSTS

Petitioner Jeane Whitfield, by and through her undersigned counsel, hereby respectfully moves for taxation of costs against Respondents Dennis K. Schimpf, M.D. and Sweetgrass Plastic Surgery, LLC (collectively, "Respondents").

This Motion is made pursuant to Rules 240 and 242, SCACR. The grounds for Petitioner's Motion are that 1) Petitioner and Petitioner's counsel expended time and resources pursuing the Appeal before the Court of Appeals and the Petition for Writ of Certiorari before the Supreme Court, 2) as a result of Petitioner's efforts, the Supreme Court reversed the Court of Appeals' Opinion, and remanded the case to the lower court for a new trial (Opinion No. 28250, Filed January 8, 2025), 3) No Petition for Rehearing was filed by the Respondents in this case, 4) This

Motion is made within 15 days of issuance of the remittitur, which was sent on January 28, 2025, 5) Pursuant to Rules 222 and 242(j), SCACR, Petitioner is permitted to pursue taxation of costs against Respondents, and 6) an Itemized Statement of Costs delineating costs necessarily incurred by Petitioner in this action is attached.
