MOTION FOR AN EXTENSION OF TIME TO
SERVE AND FILE THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for Petitioner respectfully requests an extension of thirty (30) days in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for Petitioner respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions

previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.


3. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Chavis Cox with the Court of Appeals on February 3, 2025. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Darrell Green v. State with the Supreme Court on January 15, 2025. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Terrionna M. Hart with the Court of Appeals on January 2, 2025. Counsel filed the Brief of Petitioner in the case of State v. Andres Posso with the Supreme Court on December 23, 2024. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Tyquan Jamar Johnson with the Court of Appeals on December 20, 2024. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Marcus Tyrone Grant with the Court of Appeals on December 3, 2024. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Tyquez Brisbane v. State with the Supreme Court on November 21, 2024. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Rachel Wilcox with the Court of Appeals on November 14, 2024.

4. Counsel makes this request in good faith and not for purpose of delay.


5. On January 31, 2025, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through February 28, 2025.
