NOTICE OF APPEAL



2022-GS-40-03132 – Murder / Murder – sentenced to 30 Years

2022-GS-40-03133 – Weapons / Poss. Weapon during violent crime, if not also sentenced to life without parole or death – sentenced to 5 Years - Concurrent to sentence for Murder

2022-GS-40-03134 – Vehicle / Use of vehicle without permission with intent to deprive – sentenced to 3 Years - Concurrent to sentence for Murder
