
We have been retained by Appellant Dr. Trimmier regarding petitioning the Supreme Court for certiorari in the referenced matter. The Court of Appeals denied the petition for reconsideration on August 27, 2013, and based on receipt of the order, Dr. Trimmier is informed and believes that the petition would be due for filing on October 1, 2013.
