That my employment from 2011 through 2017, as an Upholster, was not subject to the prevailing wage statute. This is incorrect as S.C. Code 24-3-430(A) lists service jobs as part of the prevailing wage statute. Also, the Department was profiting off of the work that I performed in upholstery.
