---


The undersigned counsel moves the Court to reinstate the direct appeal of Shamar L. Stanley. In support of this motion, counsel would respectfully show the Court that:

1. Trial counsel served and filed the notice of intent to appeal on November 4, 2024.
2. The Office of Appellate Defense timely ordered the transcript from the court reporter on November 12, 2024. The transcript request and cover letter to the Court Reporter are attached to this motion as Exhibit A. This Court was copied on this transcript request, as were opposing counsel, the Attorney General's Office, and Court Administration. However, a copy of that transcript request apparently was never posted on C-Track.
3. On January 30, 2025, this Court dismissed the appeal due to the failure of appellant to order the transcript as provided in Rule 207, SCACR.

4. Since appellant did timely order the transcript, undersigned counsel respectfully requests that this Court reinstate appellant's direct appeal.

WHEREFORE, undersigned counsel respectfully requests that the direct appeal for Shamar L. Stanley be reinstated.

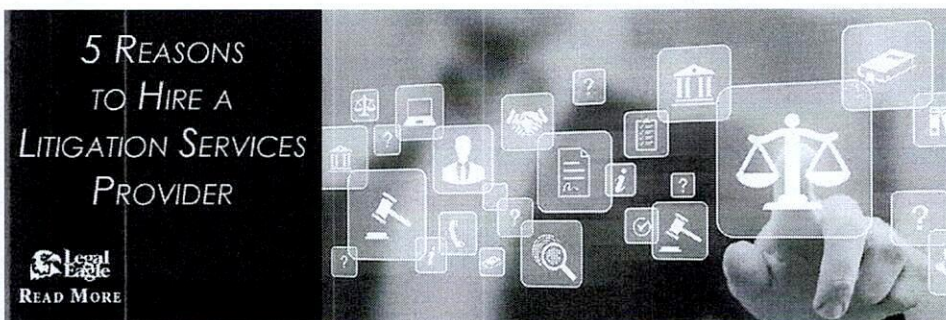


