





Enclosed for filing is a notice of appeal and proof of service in the above-captioned case. Also enclosed is a self-addressed, postage paid envelope for return to me of the additional clocked copies of the notice of appeal and proof of service.

Dwayne Cameron Tallent was indicted for Disposal of Methamphetamine Waste, 1st and Manufacturing Methamphetamine. Tallent had a trial before a jury from September 17 to September 19, 2013; found guilty by the jury on September 19, 2013; and sentenced by the Honorable G. Edward Welmaker on the above two indictments on September 19, 2013.

I have not requested the transcript, as it appears that (1) Tallent does not have the ability to retain counsel to perfect the direct appeal, and (2) the Office of Appellate Defense may assume representation in this matter. 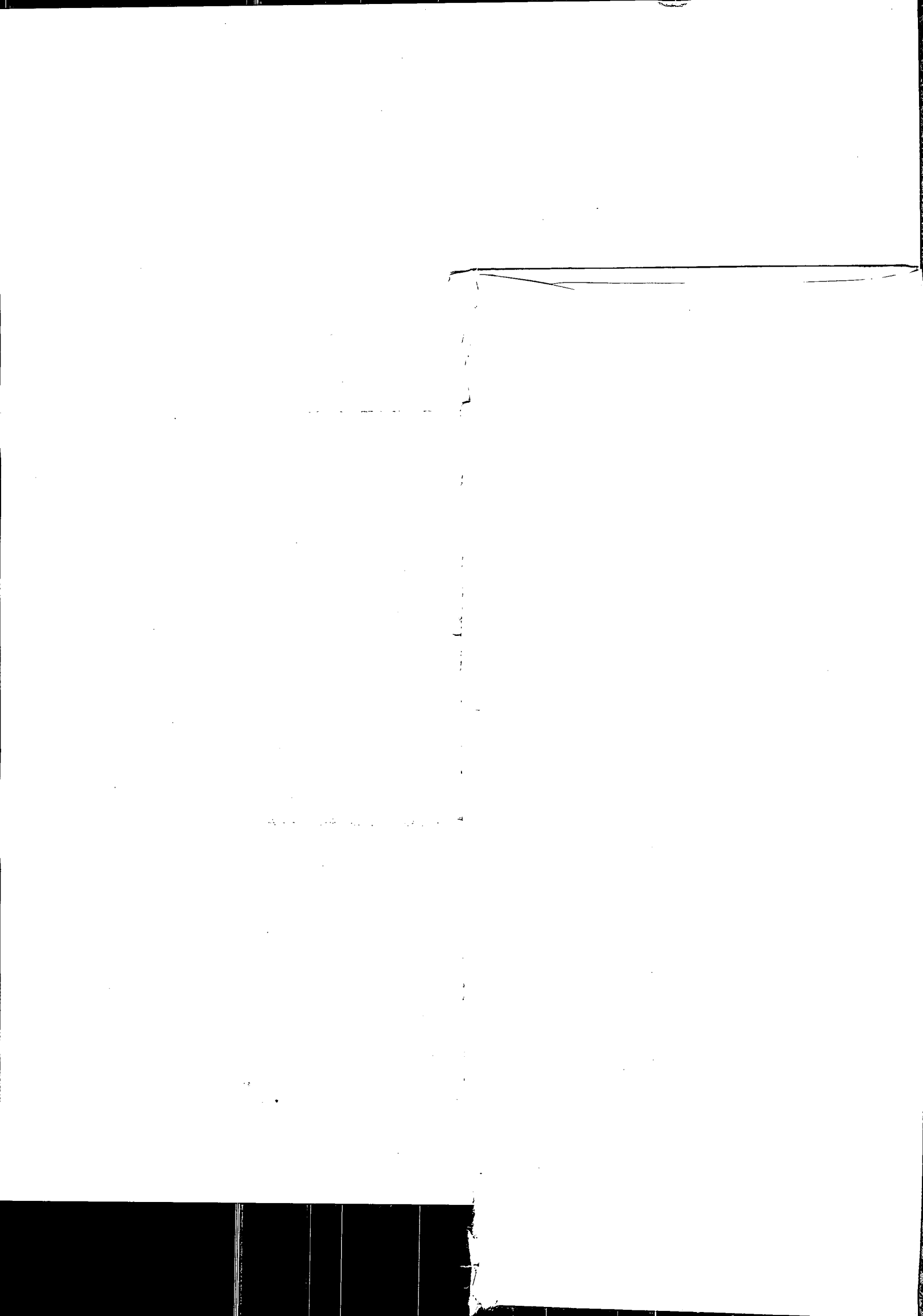

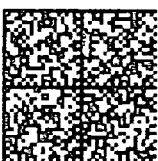
